## CM AICC NEED TO CONSIDER RB TIMMAPUR CABINET BERTH AS SC LEFT ARE DECIDING FACTORS IN MANY CONSTITUENCIES IN KARNATAKA



By: M.S.Yatnatti: Editor and Video Journalist Bengaluru: Congress has leaders and Congress will bounce back with renewed vigor .In Karnataka Dalits are number one in population as reported in Media . Congress has power .In Karnataka SC left are deciding factors in many constituencies in Karnataka and reportedly CM and AICC Leaders requested to give Cabinet Berth to Sri RB Timmapur in Karnataka Cabinet headed by Siddaramaiah as state is going to general elections in 2018 and SC left are not given proportionate representation as given to SC left right.. AICC vice-president Rahul Gandhi described the dalits as reed ki haddi'' (spine of the Congress) and said they required the escape velocity of Jupiter'' (the speed that an object needs to be travelling to break free of a planet or moon's gravity)to achieve success.

The scheduled castes (SC) and tribes (ST) in Karnataka together constitute 23.5% and account for 18% reservation in government and educational sectors (15% for SCs and 3% for STs). But the reportedly SCs left are more in numbers as Right Hand (Holayas) and Left Hand(Madigas) are distinctly identified. There is no deficit of dalit leaders across political party lines in Karnataka with the Congress having a surfeit who are heavyweights. In the vertical divide among the dalits though the Left SCs population is more in Karnataka, they feel the Rights have cornered most benefits in jobs and education. Hence, even if a leader were to emerge the sub-identity of the Dalit comes to the forefront to suppress the individual. Discontent in 'left' group of SCs may cost congress dear in 2018 election if congress do not give proper representations to SC Left . Congress need to be in social media with full power. The spokespersons have to be selected carefully. Dynamic people with good presence of mind are required to tackle the questions of the media. The way they answer the questions largely determines the impact the party has on the general public.

"The 'left' group plays a decisive role in Bellary, Chitradurga, Raichur, Tumkur, Gulbarga, Bijapur and Bagalkot Parliamentary constituencies. What is wrong in fielding candidates from the group in three constituencies?" asks a political expert . "Considering the population, the Congress should have fielded candidates from the "left" group in at least 18 of the 36 Assembly constituencies. According to statistics made available by "left" group leaders, of the total population of 5.20 crore (2001 Census) in Karnataka, the SC's share is 1.20 crore. The Left group being identified as "Yedagai" forms major chunk with a population of 60 lakh (50 per cent), the "right" group, popularly known as "Balagai", has a population of 40 lakh (35 per cent). The remaining people of the community come under Lambani, Vadda and Korama communities of SC.

Democracy is technical Majority and not peoples Majority: Few get votes and few get seats: All political parties need to understand basics of Indian Politics. It is pertinent to note that majority voters are with opposition parties. Few get votes and few gets seats .Some time BJP got seats to form the central government by securing 34 percent vote and 66 percent votes were secured by opposition parties but they failed to get the seats .It is only technical majority and not the peoples majority .First the opposition parties must thank their voters. Both the ruling party and opposition parties have to fulfill their duties as per constitution of India towards welfare of the people.

Janata Dal, Samajwadi Party, DMK, TDP, AGP, All India Indira Congress (Tiwari), four Left parties, Tamil Maanila Congress, National Conference and Maharashtrawadi Gomantak Party had established the 13-party United Front, which had formed the government. India is biggest democracy in the world and has multiparty election system. Our election is based on secret ballot system and based on multiparty systems .For one seat many parties and independent candidates contest election and the one who gets highest will get elected .It is all about master planning to win the seats .Every seat winning needs different strategy. As reported in news papers many parties got votes and did not get seats .Parties like DMK in TN, left in bengal, AAP in Delhi did not benefit from a significant vote share. At the national level, the story of votes (not seats) obtained by various parties and alliances is fairly straightforward. BJP and its allies got about 38% votes, Congress and its allies got 23%, the four major regional outfits -SP, BSP, Trinamool and AIADMK -got about 14% votes together, and the Left got about 5%. One of the biggest surprises of this election was that no candidate of the Mayawati-led Bahujan Samaj Party (BSP) won in Uttar Pradesh, which is BSP's stronghold, though it managed a creditable 20% of votes. In the outgoing Lok Sabha, it had 21 members. There are other states where a similar anomaly can be seen. In West Bengal, the Left got nearly 30% votes but had to be satisfied with just 2 seats. In Tamil Nadu, DMK and its small party allies garnered 27% votes and got no seats. In Odisha, Congress got 26% votes but no seat while the BJP got 22% and just one seat. But there is another factor to be kept in mind: the wave. In most of these states where parties with lots of votes have gone with less (or no) seats, there is one party which is getting bulk of the votes. In Tamil Nadu and in Odisha, the winning party -

AIADMK and Biju Janata Dal respectively -got an overwhelming 44% of votes. So, even if you get 25% votes you lose badly. In West Bengal, Mamata's Trinamool Congress got nearly 40% votes, outstripping its main challenger the Left front. But what explains the four seats captured by Congress getting just 10% votes. That's because these votes were gained in a concentrated belt of north central Bengal, and gave Congress an edge over others in that region. Elsewhere it was wiped out. Aam Aadmi Party (AAP) may not have performed well considering that it was much hyped in the media and had put up over 400 candidates across the country . But its y performance in two states, Delhi and Punjab, is creditae ble. In Delhi it got 33% votes, improving upon its vote share from last December's state assembly elections when it had got about 28% s votes. It lost out decisively to BJP this time round because ) BJP itself improved its vote l share to over 46%, from 33% in December. d In Punjab, AAP got nearly s 25% votes, and managed to s get four members in the Lok Sabha. This, despite the fact, that the BJP-Akali alliance got about 35% votes and the resurgent Congress 33%. In this genuinely triangular contest, everybody walked away with a few seats.

UPA government had given you RTI Act : Use It optimally :All opposition parties should use RTI optimally .Let they create booth wise RTI activists among their members or cadets and give them training and set of questions and gather that booth level information to perform better as opposition parties .Prime Minister should listen to opposition parties as they are voice of 66% voters. All responsible citizens should send RTI Question to each MP and each Minister and Prime Minister and get to know every day what they are doing and what they are performing and keep check on their performances and give them clear indication that India is awakened and want responsible Government which listens citizens.

THE RIGHT TO INFORMATION ACT, 2005 is an Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority. RTI Act provides transparency under Section 3 and 4(1) (a) (b) (c) and 2(f) of RTI Act 2005 and accountability under 4(1) (d) RTI Act 2005 as the PA will create information; or to interpret information; or to solve the problems raised by the applicants under the system and procedure as per listed Acts and rules regulations listed under 4(1) (a) (b) (c) every day and that can be cross checked by applicant by asking reasons under 4(1) (d) by the affected person and copy of the same can be given to any applicant under 2(f) of RTI Act .

RTI is a total problem solving mechanism and not just record providing tool. RTI will provide transparency under 4(1) (a) (b) (c) and 2(f) of RTI Act 2005 every day and Accountability can be ensured under 4(1) (d) and this will reduces the corruption in every public authority . RTI Act is an Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control



of public authorities, in order to promote transparency and accountability in the working of every public authority. The information under RTI Act is defined in, Section 2(f) of the RTI Act, which defines "information" provides as follows:- Definitions.- In this Act, unless the context otherwise requires,- (f) "information" means any material in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force;". This act can be called as the "law of transparency and accountability" which acts as the citizen's weapon to question and get information related to the government's functioning so that they can analyze its performance, and act accordingly.

Limiting RTI Act to 2(f) is illegal as "information" is not created in "Paraloka" or "Swargaloka" or in "CIC" as it is created under 4(1) (a) (b) (c) (d) of RTI Act. RTI Act is one of the few weapons the common man has in his fight against the high and mighty, citizens have unlimited powers under RTI Act 2005. CIC must understand that "information" is not created in "Paraloka" or "Swargaloka" or in "CIC" or "SIC" which will be given by PA under Section 2(f) of the RTI Act as it is created under 4(1) (a) (b) (c) (d) of RTI Act every day and given under Section 2(f) of the RTI Act.

It is PA which creates the information every day 4(1) (a) (b) (c) and the "information" in any form, including records, documents, memos, e-mails, opinions, advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form need to be created as per 4(1) (a) (b) (c) reasons under 4(1) (d) by the affected person and copy of the same can be given to any applicant under 2(f) of RTI Act. The PA should be forced to function and create information strictly as per under 4(1) (a) (b) (c) on the applications and request of public and provide it under 2(f) of RTI Act and information should not be incomplete misleading and false and public is free to check accountability under 4(1) (d) RTI Act 2005.

The Right to Information (RTI) Act is one of the most important tools that can empower the common man, it had become imperative to fight against corruption for the effective functioning of the three pillars of democracy — legislature, executive and judiciary. The three pillars of democracy had been included in the ambit of the RTI Act and people should make use of the provisions of the Act to bring down corruption. There was a need to create awareness among people on the wide range of powers enshrined in the RTI Act. The educated sections of society must take active part in the fight against injustice and use the provisions of the RTI Act to protect the rights of the people. "It is a 5-10 minute stop at one place and if a minister reaches a place around lunch time, he will stay for it," his aide said. According to Kumaraswamy's staff, there are days when he goes from Koramangala to Peenya to Ramanaagaram - that's one end of the city to another and back. How invitations are sent: "All invitations are routed through the leaders PAs or secretaries. Of the entire bunch, the invitations are prioritized in consultation with the leader. If there are 10-15 weddings lined up in a day, a route map is drawn up for the wedding journey," a Congress functionary said.
